#### UPDATE ON HB350 PASSAGE OF TFA COUNTY ROADS LEGISLATION

<u>A message from our TFA President Jake Almond:</u>

"We finally are close to having some legislation that will help us in the unfortunate positions we have been placed due to some unreasonable County Road Superintendants. Our House Bill 850 passed on Monday with no amendments attached. From what I understand, the



Senate now has some cleanup to do since the House Bill does not match what was passed last year in the Senate. It may not be exactly what we wanted but it is definitely a step up from the past.

I want to say thanks to everybody that has helped over the past 1.5+ years to get this done. We have had multiple meetings where TFA members have missed work to participate which shows how strong our association is. Thanks for all the phone calls, email and correspondence with your legislators. Finally, a special thanks to Tom Midyett and CandAce for all the work they have put into this legislation. Here's to a fully loaded truck leaving our landowners' forest heading on a county road to the mill!"

#### Summary of HB850/SB412

HB850/SB412 will require a 2/3 vote of a County Commission before a county road can be posted at a lower weight limit than legal weight limits. TFA believes HB850/SB412 helps alleviate the arbitrary decision making powers in certain counties. The legislation provides for better input and broader discussion before a county road can be posted damaging private property rights and market vitality in our state.

HB850/SB412 passed on the House Chamber floor on Monday evening, March 28. The Senate will vote to conform to the House legislation next week. Please contact Candace for more information or if you would like a copy of HB850/SB412.

NASHVILLE – Tennessee Gov. Bill Haslam today announced the appointment of Jai Templeton, a sixth generation Tennessee farmer, as commissioner of the Department of Agriculture effective May 1. Templeton will replace Julius Johnson who last week announced his retirement.

The past five years in the role of deputy to Commissioner Johnson have been a wonderful experience for me and I am grateful for the continuing opportunity to serve the agriculture industry," Templeton said. "As a former mayor of a rural county, it is refreshing to work for a department and administration focused on the development of rural Tennessee. I look forward to continuing the great work of this administration to strengthen our farm and forest communities all across our state."

From 1995 to 2003, Templeton served as field representative for former U.S. Representative Ed Bryant. He is a former McNairy County commissioner and former president of the McNairy County Chamber of Commerce, where he helped form the McNairy County Regional Alliance to focus on economic development in the area.

A native of McNairy County, Templeton has a bachelor's degree in business administration from Union University in Jackson, Tenn. He is also a graduate of the University of Tennessee Certified Public Administrator program.

Templeton is a member of the Agricenter International Board of Directors, the McNairy County-Chester County Cattlemen's Association, the McNairy County Forestry Landowner's Association, the Tennessee Farm Bureau, the National Cattleman's Beef Association, Memphis Ag Club, Mid-South and First Farmer's Cooperative and a former board member of the Tennessee Cattlemen's Association.

He and his wife, Allison, reside on the family farm in Stantonville and are members of First Baptist Church of Adamsville. They have three children, Canon and Eliza Smith, and Mycaela Rhodes and husband, Alex.
